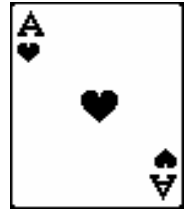

The purpose of this assumption of risk statement is to inform you and your family of the inherent risks of equine activities. Accordingly, you agree to release, discharge and agree to hold harmless and indemnify, Xanadu Ranch GetAway, Xanadu Vacations LLC, Xanadu Farms LLC and SEAHA and its owners, directors, employees, volunteers, agents and successors from any and all claims, actions and causes of action of every kind and nature whatsoever except in the instance of gross negligence or willful, wanton, or intentional acts or omissions as defined in Arizona Revised Statutes, 12-553 "Limited Liability of Equine Owners and Owners of Equine Facilities."
